- (1) The conduct of the parade will not substantially interrupt the safe and orderly movement of other traffic contiguous to its route.**
- (2) The conduct of the parade will not require the diversion of so great a number of City police officers to properly police the line of movement in the areas contiguous thereto as to prevent normal police protection for the city.**
- (3) The concentration of persons, vehicles, and animals at assembly points of the parade will not unduly interfere with proper fire and police protection of, or ambulance service to, areas contiguous to such assembly points.**
- (4) The conduct of the parade will not interfere with the movement of any emergency vehicles.**
- (5) The conduct of the parade shall not cause injury to persons or property or provoke disorderly conduct or any disturbance of the peace**
- (6) The parade will be scheduled to move from its point of origin to its point of termination expeditiously and without unreasonable delays.**
- (7) The parade will not be held purely for private gain and shall not be for the sole purpose of promoting or advertising any product, good, or event.**
- (8) No throwing of candy or other objects along the parade route.**
- (9) I/we understand that the Director of Public Safety shall have the authority to revoke this Parade Permit for any violation of these guidelines; the City's Parade Ordinance; or any city, state, or federal ordinance or law.**
